2. **From Northern Alaska Environmental Center (NAEC):**

709 acres on Gilmore Dome: Comment period open

The Gilmore Satellite Tracking Station is located on 8,855 acres of federally withdrawn lands adjacent to Fort Knox mine. NOAA notified BLM last fall, with an interest to relinquish 709 acres of the withdrawal. This area is top filed by the State of Alaska for mining claims, and Fort Knox has been doing exploration work in area. BLM will determine whether this partial relinquishment is "suitable for return to the public domain" and [is accepting public comments until May 22](#). ICYMI: Executive Order Revokes Arctic Protections

A broad coalition of Alaskans reacted with outrage to President Donald J. Trump's impending executive order released Thursday, revoking oil and gas protections in vast swaths of Alaska's Chukchi and Beaufort Seas. 3. During 2016, 128 drug overdose deaths occurred in Alaska; of these, 95 involved any type of opioid

(including prescription opioids, heroin, or other) Subsequent to Governor Bill Walker's declaration of the opioid epidemic as a public health disaster in February 2017, Alaska Project HOPE (Harm reduction, Overdose Prevention, and Education) has been providing overdose reversal kits with prepackaged naloxone nasal spray (4mg/0.1mg dose) to overdose prevention programs...A public information campaign has been launched to call attention to the risk of opioid addiction and to reduce stigma by increasing the understanding of addiction as a chronic health condition rather than a moral failing. 4. -from CODEPINK: As Saudi woman living in the United States and campaigning for women's rights, I was disgusted when I heard that Saudi Arabia, one of the worst human rights and women's rights violators, was just elected to the UN Commission on the Status of Women by a secret ballot. The United States is a leading voice on that commission, but the U.S. Ambassador to the UN, Nikki Haley, probably voted in favor of the Saudi regime and refuses to speak out against this outrageous hypocrisy.

Women are forced to be covered in public and are subjected to a **strict guardianship system** that requires a male relative's **permission to travel, attend school, obtain work, or even seek medical attention.** Saudi Arabia is the only country in the world to **ban women from driving**, a practice that severely limits women's independence and autonomy.

Allowing the **most misogynist society in the world** to join a commission designed to empower women is **disgraceful!** It makes me feel personally violated and invisible. It is a slap in the face to heroic women around the world who risk their lives every day to achieve their rights. It jeopardizes the integrity of the United Nations itself.
