--from Tanana Chiefs Conference The Council Newsletter: "**Sobering Center Dedication and Open House**...This shelter is modeled after the sobering center in Bethel...[and] has the ability to hold 12 clients at any given time...accommodate varying numbers of male and female guests [who] can shower and do laundry as needed. Guests are admitted to the Sobering Center for a 12-hr sleep off in a warm and safe environment...[S]creenings can lead to resources that may help break the cycle [of addiction]. Guests will be referred to appropriate services to address their substance use disorder...TCC, DHHS, the Alaska Mental Health Trust Authority, Fbks Memorial Hospital, City of Fbks, Fbks Police Dept, Fbks Native Association, and numerous other supporting partners made this program possible."

"Contrary to what is normally taught, growth is not necessary for prosperity and well-being.

[Costa Rica](#) demonstrates that prosperity can exist with a low per capita income through investments in social necessities such as education and health care... Every few years the New Economics Foundation publishes the

[Happy Planet Index](#) – a measure of progress that looks at life expectancy, wellbeing and equality rather than the narrow metric of GDP, and plots these measures against ecological impact. Costa Rica tops the list of countries every time. With a life expectancy of 79.1 years and levels of wellbeing in the top 7% of the world, Costa Rica matches many Scandinavian nations in these areas and neatly outperforms the United States. And it manages all of this with a GDP per capita of only \$10,000, less than one-fifth that of the US. In this sense, Costa Rica is the most efficient economy on earth: it produces

high standards of living with low GDP and minimal pressure on the environment. How do they do it? ... universalism: the principle that everyone – regardless of income – should have equal access to generous, high-quality social services as a basic right... healthcare, education and social security ...to the whole population ... after abolishing the military and freeing up more resources for social spending.”

Writer, naturalist, and Encounters Radio host Richard Nelson shares his enthusiasm for the natural world we live and rejoice in, in a way that makes us hear, see, and feel his encounters with wildlife as if we were there too. He is also partially responsible for the creation of KWRK-LP radio, as Encounters was one of several prime-time programs cut by our local PBS station a bit over a decade ago, inspiring his enthusiastic listeners to make a station whose programming would be responsive to those whose valued programs were cut...and he came up to Fbks to help get us started.

-from www.heyfairbanks.net: ‘**Hey Fairbanks...WHERE'S MY INTERNET?** If ... you're like me, you have problems with Internet If YOU don't then I can tell you that your neighbor and many others in our community do. This web site offers a solution.

Many communities across the United States have broadband problems and they are repurposing an old tool to solve a new problem. We can do that too.

In the 1930's electrical utilities were not extending power out to rural America. President Roosevelt signed the Rural Electrification Act, enabling the creation of rural electric cooperatives, and we extended power across the country. Imagine if we had never electrified rural America, who would have been feeding the nation?

We discovered that today, there are some 53 electric coops across the US deploying fiber optic broadband to their members. I spoke to a number of them and they all told the same story of member driven success.

These communities decided they would do for themselves what others wouldn't do for them. They got their member owned electric coops to string fiber optic cable on the power lines. It's time to show our grit and determination. It's time to demand a solution.

As you'll see on this site, this isn't the only solution, and I'm not saying just go ahead and build a network. I'm saying let's get our electric coop to find out if this model is feasible in Fairbanks, Alaska.

In short...Here's what we have to do. We have to convince Golden Valley to investigate the idea of deploying fiber optic cable to its members. Don't let them give you excuses. Don't take no for an answer. Call the Board of Directors (their names and phone numbers and maps of their areas are on this web site) and tell them you're a member and that you want them to follow up on this. It's just that simple, but it's going to take all of us." *The [Office of Representative](#)*

C8, the industrial fluoride-based chemicals, are in Fairbanks area groundwater. While not manufactured here, they were used in fire-fighting training, as required by the federal government. Wells have been destroyed; rendered useless.

It behooves everyone who drinks water, bathes, swims, cooks, raises animals, gardens or children, to LISTEN UP. It's poison. It will kill you...but before that it will make life miserable and your doctors wealthy.

New Jersey and Vermont have taken the lead in protecting citizens. Regulations in these states ought to be the template for setting standards in Alaska. Currently, C8 is UNREGULATED IN ALASKA and unregulated by the federal EPA. Alaskans will be engaged in implementing national safety regulations and mitigation requirements."

-- Thinking ahead to the **Alaska Legislative session that starts Jan. 16, 2018**, from Sen.Berta.Gardner@akleg.gov: "Dear Friends and Neighbors, I hope this finds you all happy and healthy during the holiday season and able to celebrate with family, friends & loved ones. This is also a season when legislators prepare for the upcoming session, considering new legislation to offer or existing proposals to pursue. While the budget remains the critical issue, I want to take a minute to share how some of your ideas become potential legislation, and how we look into issues and concerns for resolution or solution.

"Constituents contact me using every option available: phone, email, paper mail, and social media. I frequently run into people at the grocery store, community council meetings, the dog park, etc. They ask questions and raise issues... Some examples of the kinds of things we look into: We received an email about a Board of Game proposal to remove goats & sheep from ...a certain distance of Dall sheep populations...Fish and Game ...ultimately determined that they lacked jurisdiction over domestic animals. ... a Facebook message asking about Alaska's policy on marriage following national reports on child marriage, including the fact that in Alaska children as young as 14 are permitted to marry with the permission of a superior court judge. We used the services of legislative research staff and the National Conference of State Legislatures (NCSL) to research and decided to propose legislation setting the minimum age for marriage at 18, or approval of legal emancipation for those over 16. Emancipation requires a demonstration that the person can be self-supporting and approval by a judge..."

I hope this gives you some idea of our process, and as always, invite you to share your concerns, ideas, and to let us try to help solve a problem with a government agency."

AP **UNITED NATIONS** — The U.N. Security Council unanimously approved tough new sanctions against North Korea on Friday in response to its latest launch of a ballistic missile that Pyongyang says is capable of reaching anywhere on the U.S. mainland... President Donald Trump tweeted the 15-0 vote, adding: "The World wants Peace, not Death!" China's deputy U.N. ambassador, Wu Haitao, said it's "imperative" to pursue a peaceful settlement and resume dialogue and negotiations at an early date, warning that resorting to force "will only lead to disastrous consequences."

12/17/17: "News-Miner opinion: **Fairbanks** has a **homelessness problem**, and every winter it is compounded when temperatures dip below zero. As Fbks Mayor Jim Matherly has said on multiple occasions, "It's a matter of life and death." Significant progress has been made in the last year or so in combating homelessness:..Prosperity House opened with 15 rooms in Sept 2016... 15 more rooms were added, ... providing recently incarcerated people with a place to live. It can be extremely difficult for people who have a criminal record, no credit history, and no rental history, to find housing. Fbks Youth Advocates served 112 teens at its 12-bed shelter, The Door, in the first 11 months of 2017... Mr. Sanders ... Fbks housing and homeless coordinator...- brought to Fairbanks through a state grant... organizing and directing all of the community's housing and homeless resources on a full-time basis...- said 83 percent of people who go through a rapid rehousing program never go homeless again..."

--from **Edward Snowden**, ACLU Action aclu@aclu.org on 12-20-17: "Eleven days from now[12-31-17], the U.S. government's most powerful mass surveillance law will expire. But instead of seizing the opportunity to rein in some of the government's worst abuses, Congress is poised to make a bad situation even worse.

It's critical that every one of us calls our House representatives to stop a dangerous expansion of warrantless government surveillance. [Rep. Don Young in Fbks 456-0210; in D.C. 202-225-5765]

In 2013, I shared documents with journalists that revealed the breathtaking scope of the United States' mass surveillance programs, sparking global outrage and historic reforms. But Congress has failed to reform Section 702, and some members are working to drastically expand its powers. The government uses that law to collect our emails, text messages, phone calls, and more. It can be used to target journalists, human rights activists, and ordinary citizens who have done nothing wrong, without meaningful oversight.

I've made it clear that I don't think any administration should have this power over its people. But the thought of this kind of unchecked power in the hands of the [current] administration, which has made clear its desire to abuse the government's surveillance systems, is chilling...

The last time a major surveillance law was set to expire, the people organized to demand reform – and they got it. This time, the House is rushing this bad bill through Congress in the hopes no one will notice...

'Dear Brothers and Sisters,

Tuesday morning at 3am, Israeli forces invaded my home and **arrested my daughter. They dragged Ahed out of bed, handcuffed her and put her in the back of their military jeep. She is 16 years old.**

The next morning, my wife went to the police station to be with our daughter as she was interrogated. But Israel **took her into custody as well**. The following day, **they arrested my 21-year-old niece Nour**.

This is too much! Israel must immediate release the Tamimi women! They must stop their persecution of my family. All of this started with last Friday when **soldiers in my village shot 15-year-old Mohammed Tamimi directly in the face with a rubber coated steel bullet**. Following surgery, Mohammad had to be placed in a **medically-induced coma**. Then the soldiers came to our home. Ahed and Nour slapped the soldiers in the face and pushed them back, yelling that they could not enter our home.

The Israeli military is threatened by our regular protests, by our refusal to live with occupation.

Ahed appeared in court yesterday. Her detention was extended because she is refusing to talk. **No cooperation with the occupation!** Nour and my wife, Nariman, appeared in military court today. Their **detention was also extended until at least Monday**. Ahed, Nariman and Nour are **being held Hasharon prison**. Ahed is being held with Israeli prisoners and Nariman and Nour are being held with Palestinian prisoners. Even though Ahed is not in the same section of the prison as her mother and cousin, she is remaining strong and determined.

Tell the Israeli military to release my family and end their 50 year long occupation of our land.

It is our responsibility to resist the soldiers who enter our village and settlers who occupy our land and resources. For our family's work, I have been recognized by the European Union as a Human Rights Defender. **At the age of 13, my daughter won the Handala award for Courage in Turkey.** Amnesty International, during one of my imprisonments, declared me a prisoner of conscience. Each week, my wife helps lead our anti-occupation demonstration. Now her resistance takes place from the inside of an Israeli jail.

Tell the Israeli military to release my family and end their 50 year long occupation of our land.

People and organizations around the world from Youth Against Settlements in Palestine to Jewish Voice for Peace, CODEPINK and others in the US are supporting us. They are writing press releases, making phone calls and standing by our side. **[12/22] at 12pm EST, (7pm Palestine time) there [was] a twitter storm with the hashtag #FreeAhedTamimi.** I thank everyone for their support and hope my family will be free soon.
