Berta Gardner 5/10: “<a href="#"><u>HB 312 – Crimes Against Medical Professionals And More!</u></a> Today the Senate passed this bill which started out as addressing violent crimes against medical professionals. We added several of the Governor’s crime bills, turning it into an omnibus crime bill of sorts. The bill now includes:</i></p> <ul style="list-style-type: none"><li><i>· <a href="#"><u>SB 146/HB 291</u></a> – Allows the Attorney General to schedule substances by emergency regulation. 
