In advance of the summit, the Trump administration said that an agreement with North Korea will be in the **form of a treaty**. from [Friends Committee on National Legislation](#): "**Support a Tribal Set-Aside in Crime Victims Fund** In some rural communities, Native women face a murder rate that is ten times higher than the national average. Despite having crime rates significantly higher than the rest of the country, Native victims in these communities are less likely to receive assistance and services.

As a member of the Senate Appropriations Committee, your senator, Sen. Lisa Murkowski, can help by supporting a 5% tribal set-aside of the Crime Victims Fund. **Will you urge her to support a 5% tribal set-aside?**

The CVF is unique in that its funding comes from offenders, not taxpayers, and it goes directly to help victims of crime. But without this intentional allocation of the CVF, tribal communities have limited access to funding, despite having the highest rates of crime. Native communities need at least a 5% set-aside to get the resources necessary to heal and prevent crime.

Please contact Sen. Murkowski now and urge her to support the tribal set-aside in the CVF. With your support, this set-aside will fund victim services within tribal justice systems and will both prevent crime and violence and help victims and their families heal.

“During its May 31 mtg..., the UA Board of Regents approved a plan to **eliminate the School of Natural Resources** and Extension and move the school's academic degrees to the College of Natural Science and Mathematics, effective June 30, 2019. Under the plan, Extension will return to being a stand-alone unit. A committee of academic faculty from both units provided input on the decision. Planning for the transition will continue for the next year. All of the school's bachelor's, master's and doctoral degrees will continue to be offered.

“**Revised solar design manual released**

Extension has released a new edition of "A Solar Design Manual for Alaska." Energy Specialist Art Nash and Chris Pike and Erin Whitney, research engineers with the Alaska Center for Energy and Power, updated the manual, which was written by former energy specialist Rich Seifert and first published in 1981. The fifth edition includes many updates, an expanded section on solar photovoltaic technology and two new appendices. One includes case studies of Alaskans who use solar energy, and a second appendix describes how to use solar energy to heat greenhouses and extend the growing season.

The guide includes information on solar design, components, current standards and codes, solar economics and financing, solar heating technologies, passive solar heating and active solar water heating.
