The International Tribunal for Natural Justice launched the Judicial Commission of Inquiry into Human Trafficking and Child Sex Abuse at an inaugural seating in London April 16-18th 2018... The principal intention behind this Commission is not to instigate witch-hunts or target individuals, but to set in motion a culture that ensures restoration of truth, disclosure and reconciliation around the subject of human trafficking and child sex abuse. Our goal is to achieve in 9 - 12 months what governments and leaders of the world have failed to do for centuries - shed the full light of truth on the nature and extent of the human trafficking and child sex abuse pandemic.. An Official Commission Report will be published and issued to the world-at-large at the Declaration event in Rome at the close of the Inquiry.

**Treaty of the International Tribunal for Natural Justice...***[to which persons may sign]*  
We, according to the solemn duty as aforesaid, and per the dictate of conscience, ratify the present treaty with the earnest intention that truth and reason be restored to the delivery of justice in the world.

And so, recognising that in Truth:

- i. Law in its purest form requires nothing more or less than that we each do no harm.
- ii. Harm in any form is only ever caused by natural persons, regardless of whether or not the natural person may claim to be operating under corporate dictate, colour of law, or otherwise.
- iii. Harm in any form is only ever capable of being suffered by natural persons, regardless of whether or not the harm suffered may have been so suffered through a natural person's artificial externalities.
- iv. Neither corporate immunity, nor colour of right, can indemnify a natural person for harm caused to another.
- v. No natural person is bound by the unlawful ruling of a de facto court where they are not a consenting party with full knowledge of the manner in which their consent is given.

We the natural men and women of the world, pursuant to the ultimate goal of realising equal

Force personnel, civilian contractors and dependents — are projected to arrive by 2022. ...The mass of people arriving in the borough creates a number of challenges.
