**"The Yukon-Kuskokwim River Alliance was formed in Bethel** to oppose Donlin, and in the last month has already recruited over 500 members throughout the region. Four tribes, Tulusak, Chuloonawick (Emmonak), Nunapitchuk, and Orutsarmiut Native Council, have joined in opposition, and have passed resolutions against the mine.

"If built, Donlin would be one of the largest mines in the world and could have major impacts on subsistence resources, water quality, and traditional ways of life. Increased barge traffic on the Kuskokwim could hasten erosion and endanger smelt spawning while the open pit mine itself would increase mercury levels in the water and require water treatment in perpetuity – as close to forever as anyone can guess.
