When the Palmer Police Department (PPD) arrived, they let the three assailants go free and instead took Alex to jail for four days for no other reason than Immigration and Customs Enforcement (ICE) had issued a detainer warrant.

Alex Caceda had committed no crime.

The City of Palmer chose to settle our lawsuit rather than see it go to court. In exchange for dropping his lawsuit, Caceda received a written apology from the City of Palmer and \$50,000 in compensation. The City of Palmer has also agreed to make the following changes to PPD’s Standard Operating Procedures dealing with immigration warrants and detainees:

- Direction that an ICE warrant shall be treated as administrative and not a criminal warrant unless the warrant is signed by a neutral magistrate or judge.

- Acknowledgment that PPD values the diverse population of the community it serves.
- Acknowledgment that unauthorized presence in the United States is not a crime and enforcement of civil violations of unlawful presence is reserved for ICE.
- Express statement that officers shall not stop or detain an individual based on the knowledge or suspicion that the person is in the United States without authorization.
- Recognition that the following ICE detainer and hold requests are never criminal and require no analysis to determine that they are administrative: I-200, I-203, I-205, I-247.
This is a stunning and unequivocal acknowledgement by the Palmer Police Department that local police have no legal authority to arrest or detain anyone just for being undocumented, even if ICE requests it. The ACLU of Alaska is sending [this letter](#) to every local police chief in Alaska reminding them of this and asking them to review their own operating procedures with their rank and file officers to ensure a case like this does not happen in their jurisdiction.
We ask you to also forward that letter your own local police chief and request similar action. We’ve won this case and the law is clear, but we must all remain vigilant of overzealous and unlawful enforcement against Alaska’s most vulnerable communities.”

“Hello this is the Asymmetric Moose with the Alaska Peace Center News Music picks for the week.*

The following is a reading from American Naturalist and philosopher John Muir’s “The Story of My Boyhood and Youth”.

“I well remember my father’s discussing with a Scottish neighbor, a Mr. George Mair, the Indian question as to the rightful ownership of the soil. Mr. Mair remarked one day that it was pitiful to see how the unfortunate Indians, children of Nature, living on the natural products of the soil, hunting, fishing, and even cultivating small corn fields on the most fertile spots, were now being robbed of their lands and pushed ruthlessly back into narrower and narrower limits by alien races who were cutting off their means of livelihood. Father replied that surely it could never been the intention of god to allow Indians to rove and hunt over so fertile a country and hold it forever in unproductive wildness, while Scottish and Irish and English farmers could put it to so much better use. Where an Indian required thousands of acres for his family, these acres in the hands of industrious, god-fearing farmers would support ten or a hundred times more people in a far more worthier manner, while at the same time helping to spread the gospel.

Mr. Mair urged that such farming as our first immigrants were practicing was in many ways rude and full of mistakes of ignorance, yet, rude as it was, and ill-titled as were most of our Wisconsin farms by unskilled, inexperienced settlers who had been merchants and mechanics and servants in the old countries, how should we like to have specially trained and educated farmers drive us out of our homes and farms, such as they were making the same argument, that god could never have intended such ignorant, unprofitable, devastating farmers as we were to occupy land upon which scientific farmers could raise five or ten times as much on each acre as we did? And I well remember Mr. Mair had the better side of the argument. It then seemed to me that, whatever the final outcome might be, it was at this stage of the fight only an example of the rule of might with but little or no thought for the right or welfare of the other fellow if he were the weaker; that “they should take who had the power, and they should keep who can,” as Wordsworth makes the marauding Scottish Highlanders say.”
