Washington became the 20th state to abolish capital punishment and the third state to do so on the basis of racial disparities...

Here's what the data say: Black people make up 13% of the U.S. population, but 42% of people on death row and 31% of the total incarcerated population; 69% of the 362 DNA exonerees are people of color, and 61% are black; 65% of DNA death row exonerees are people of color...

Courage to Resist is now a project of the Church of Conscious Objection (CCO), a 501(c)(3) charitable organization (EIN 83-1810568). The "Objector Church" embraces the historic legacy of religious humanism, with a simple doctrine: To do the right thing, guided by an embrace of humanity and a rejection of war and militarism. It's a non-denominational peace and justice ministry, so everyone is welcome.

Aside from supporting Courage to Resist, the church will be launching a **national conscientious objection registry**. Right now, every young man in the United States between the ages of 18 and 25 is required by law to register for the draft. As we've been writing about, it's likely that this forced registration will soon be **expanded to women** as well, since all military jobs are now open to women for the first time.

The Selective Service System has no method of (or interest in) recording an individual's objection to participating in war at the time of registration. The church will provide **counseling** and options such as **notarized letters of support** for an individual's conscientious beliefs. These will serve as evidence of previously held beliefs in the case of a draft.
