**"School of the Americas (SOA) renamed** the Western Hemisphere Institute for Security Cooperation (**WHINSEC**) in 2001, is a US military training school based in Fort Benning, Georgia. The school made headlines in 1996 when the Pentagon released training manuals used at the school that **advocated torture, extortion and execution**. Despite this admission and hundreds of documented human rights abuses connected to soldiers trained at the school, no independent investigation into the facility has ever taken place... Since it was founded, over 80,000 Latin American military and police officers have received training in the SOA / WHINSEC. Among the list of **graduates are some of the worst violators of human rights in the continent, including** nearly a dozen Latin American **dictators**... **SOA Watch** is a nonviolent grassroots **movement working to close the SOA / WHINSEC** and similar centers that train state actors such as military, law enforcement and border patrol. We strive to expose, denounce, and end US militarization, oppressive US policies and other forms of state violence in the Americas. We act in solidarity with organizations and movements working for justice and peace throughout the Americas." from SOAW.

\*[from Wikipedia](#): "In 2000, the [US Congress](#)... withdrew the [Secretary of the Army](#)'s authority to operate USARSA.<sup>11</sup> The next year, the institute was renamed to **WHINSEC**. [U.S. Army](#) Maj. Joseph Blair, a former director of instruction at the school, said in 2002 that "there are **no substantive changes besides the name**. ... They teach the identical courses that I taught and changed the course names and use the same manuals..."

“In 2005 a bill to abolish the institute, with 134 cosponsors, was introduced to the [House Armed Services Committee](#).<sup>[24]</sup> In June 2007, the McGovern/Lewis Amendment to shut off funding for the Institute failed by six votes.<sup>[25]</sup> This effort to close the Institute was endorsed by the [Council on Hemispheric Affairs](#), which **described the Institute as a “black eye” for America**.<sup>[26]</sup><sup>[8]</sup>

-- “Hello this is the Asymmetric Moose, Rob Mulford, with the picks of the week of Nov. 10, 2010. The week of the holiday that runs closest to my heart, Armistice Day. Veterans For Peace has been celebrating Armistice Day almost since the organization's inception, with a few chapters doing yearly events. However, in 2008 the effort became a national effort with the passage of an official Veterans For Peace resolution. Since then, chapters across the country have been "Reclaiming Armistice Day" pushing the celebration of peace into the national conversation on Veterans Day.

Over one hundred years ago the world celebrated peace as a universal principle. The first World War had just ended and nations mourning their dead collectively called for an end to all wars. Armistice Day was born and was designated as “a day to be dedicated to the cause of world peace and to be thereafter celebrated.” After World War II, the U.S. Congress decided to rebrand November 11 as Veterans Day. Honoring the warrior quickly morphed into honoring the military and glorifying war. Armistice Day was flipped from a day for peace into a day for displays of militarism.

Veterans For Peace has taken the lead in lifting up the original intention of November 11th – as a day for peace. As veterans we know that a day that celebrates peace, not war, is the best way to honor the sacrifices of veterans. We want generations after us to never know the destruction war has wrought on people and the earth.

Veterans For Peace is calling on everyone to stand up for peace this Armistice Day. More than ever, the world faces a critical moment. Tensions are heightened around the world and the U.S. is engaged militarily in multiple countries, without an end in sight. Here at home we have seen the increasing militarization of our police forces and brutal crackdowns on dissent and people’s uprisings against state power. We must press our government to end reckless military interventions that endanger the entire world. We must build a culture of peace.

First I'll start with a reading of Wilfred Owen's heartfelt poem that rings with truth about military recruiting. He wrote these words sometime between October 8, 1917 and March 1919. Unfortunately he was killed in action exactly one week before the Armistice to end World War One was signed.

#### **DULCE ET DECORUM EST**

Bent double, like old beggars under sacks,  
Knock-kneed, coughing like hags, we cursed through sludge,  
Till on the haunting flares we turned our backs  
And towards our distant rest began to trudge.  
Men marched asleep. Many had lost their boots  
But limped on, blood-shod. All went lame; all blind;  
Drunk with fatigue; deaf even to the hoots  
Of tired, outstripped Five-Nines that dropped behind.  
Gas!(7) Gas! Quick, boys! – An ecstasy of fumbling,  
Fitting the clumsy helmets just in time;  
But someone still was yelling out and stumbling,  
And flound'ring like a man in fire or lime . . .  
Dim, through the misty panes and thick green light,

As under a green sea, I saw him drowning.  
In all my dreams, before my helpless sight,  
He plunges at me, guttering, choking, drowning.  
If in some smothering dreams you too could pace  
Behind the wagon that we flung him in,  
And watch the white eyes writhing in his face,  
His hanging face, like a devil's sick of sin;  
If you could hear, at every jolt, the blood  
Come gargling from the froth-corrupted lungs,  
Obscene as cancer, bitter as the cud  
Of vile, incurable sores on innocent tongues,  
My friend, you would not tell with such high zest  
To children ardent(14) for some desperate glory,  
The old Lie; Dulce et Decorum est  
Pro patria mori.  
(Sweet and honorable it is to die for your country.)

***This is our cry, this is our prayer, peace in the world.*** **Sadako Sasaki** was only two years old during the atomic bombing of Hiroshima. She survived, becoming one of the most widely known *hibakusha* – a Japanese term meaning "bomb-affected person". She is remembered through the story of the one thousand origami cranes she folded before her death, and is to this day a symbol of the innocent victims of nuclear warfare. It's taken most of my life to come to the realization that I, as a descendent of a settler race, who have taken so much from the indigenous first peoples of this land, owe them for most of the blessings that I have received living here. I owe it to them to at least attempt to undergo a process of decolonization. And so, being an elder now whose property taxes have been lessened, I have decided to pay the taxes that I otherwise would have paid the Borough government to Fairbanks' Native Movement to help them in their decolonization project, a worthy and vital cause if there ever was one. Think about it. If you, like me are a member of a settler race. You can never repay the injury done in the past, but you may be able help correct the ones that are ongoing to this day.
