## OTHER News and Opportunities for Action:

**from Delta Wind, 1-31-20:** "Alaska Court System Jury Summons now sent by email... By November of 2019, courts statewide were sending these jury documents by email... If the email is not responded to, the court mails a postcard... In 2019, 24,888 people appeared for both trial and grand jury duty in Alaska... The majority of Alaskans

summoned as jurors serve as trial jurors and are asked to hear evidence presented at a trial, decide the facts, apply the facts to the law explained by the judge, and return a verdict. ...[T]o serve as grand jurors... is different from service on a trial jury. There is no judge involved in the grand jury process. A prosecutor presents evidence to the grand jury, which decides whether there is enough evidence to charge a person with a crime. If the grand jury decides to charge a crime, then the prosecutor decides whether to take the case to a trial where a trial jury will decide if the person is guilty of the crime. Always check emails to make sure links go to [courts.alaska.gov](https://courts.alaska.gov) and not a fake page. The Alaska Court System is not aware of any phishing or scams on Alaskan jurors by email, but there have been many instances in which scammers call Alaskans asking for fine payments, which the court system does not do. The login screen for the online juror questionnaire asks for the last four digits of a potential juror's social security number, but not the entire number. **\* Regarding Board of Game mtgs March 6-14:** *per ADF&G*, "Topics to be addressed within the Interior and Eastern Arctic Region include hunting and trapping seasons and bag limits for residents and nonresidents, restricted and management areas including closed areas to hunting and trapping wolves near Denali National Park, methods and means, salvage requirements, hunting permits and conditions, and intensive management plans. The board will also address annual reauthorizations of antlerless moose hunts and resident brown bear tag fee exemptions statewide. *Per Alaskans For Wildlife*: "Alaskans FOR Wildlife is asking the Board Of Game (BOG) to AMEND PROPOSAL 152 to enact a year-round no kill buffer as enacted in HB 105 by the House of the Ak Legislature in 2017, but to include not only Denali Park wolves but also bears black and brown, wolverine, lynx and coyotes that stray outside northeastern park bounds and, without the buffer get legally killed at bait stations, in snares and traps or shot on site. Proposal 152 would allow killing August through January and halt it during only spring months... Any support for 152 unfortunately is a way to ensure the BOG will likely not again accept proposals for the needed year round buffer that once existed."

**\*\* Regarding BLM Resource Advisory Council position nominations:** *[from Delta Wind 1-28-20]* "The Bureau of Land Management (BLM) is seeking nominees for its Resource Advisory Council (RAC) from the general public, government, Native organizations, archaeological and historic organizations, recreation users, environmental organizations, energy and mineral development, and other BLM land users. The council consists of 15 Alaska residents who, through consensus, develop recommendations for public land management policy. The RAC meets 2-3 times per year over 1-3 days... "Members are needed from various, and potentially opposing, interest groups. That diversity is truly reflective of the multiple use mission of the BLM, and it is critical to the RAC's success." *from erica@northern.org*: "Trilogy Metals and Australian mining company **South32 finalized a Joint Venture to create the LLC Ambler Metals**. As a part of the Joint Venture, South32 invested more than \$100 million dollars to develop mines in the Brooks Range... despite staunch opposition ...from the communities in the region who would be most impacted by losses in subsistence resources and increased non-local access to the area... [and] development of this Joint Venture's mines relies on the construction of the notorious proposed Ambler road... The road's Final Environmental Impact Statement is expected to be released sometime in March of this year. This is an extraordinarily short turn around.

"Along with our national coalition, we're reaching out to businesses from around the U.S., asking you to add your name to this statement: **We ask oil and gas corporations and the other businesses that support drilling activities to not violate the Refuge's biological heart, the coastal plain, and to listen to the will of the people. We must hold our national treasure in trust for future generations.** Business owners, **please sign on**, pass on to your friends and colleagues, and help make sure our elected leaders hear from businesses around the country who stand together in defense of the sacred coastal plain."

*from Fairbanks Daily News-Miner 2-17-20*: "One **defensive strategy against surprise medical bills**: Set your own terms...Instead of simply signing the hospital's financial and treatment consent form, Richter first crossed out sections calling for her to pay whatever amount the hospital charged. She wrote in...a 'maximum of two times' what the federal government would pay under Medicare, which is in the ballpark, experts said, of what hospitals might consider an acceptable rate... Some legal scholars question the premise that hospitals' financial consent



forms are themselves valid contracts. That's because contract law requires 'mutual assent,' something... patients can't really give because they are seldom told the true price of care up front before signing..."

2-16-20: "President Trump's federal **budget plan** for fiscal year 2021, which begins in October, includes **close to \$1 trillion in cuts to Medicaid**...[It] also requires all states to establish work requirements for Medicaid recipients... [The] proposal has gone to Congress, which ultimately develops and approves a budget it then sends back to the president for his signature... at the same time the Trump administration is supporting a Texas lawsuit seeking to do away with the AC [Affordable Care Act] entirely..."

Assange’s alleged crimes date back to 2010, when the organization he founded, WikiLeaks, transmitted documents to media outlets including Le Monde, The Guardian and The New York Times. The documents, which were provided to WikiLeaks by whistleblower Chelsea Manning, included 250,000 US diplomatic cables and US army reports about military operations in Iraq and Afghanistan, and **exposed cases of torture, abduction and disappearances**.

**“As an anti-war organization, we have found these documents critical to understanding our government’s actions.** The publication of these documents by media outlets was clearly in the public interest, and not an act of espionage.

“If the legal persecution of Assange continues, investigative journalism and press freedom will be the victims, since news organizations regularly rely on and publish classified information to serve the public interest...”. “Exposing Crimes is Not a Crime. #FreeAssange. #FreeSpeech. #EndWar. One of the first things we teach our children is, ‘See something, Say something.’ Except for war crimes, genocide, and government crimes?”

Over 20,000 military members were sexually assaulted in 2018. A third of the victims were discharged after reporting typically within 7 months of making the report and those victims received harsher discharges with 24% being separated under less than fully honorable conditions compared to 15% of all service members. 64% of women who reported a sexual assault faced retaliation, and in over 1 in 4, victims who did not report, feared retaliation from their commander and co-workers. Despite a 22% increase in unrestricted sexual assault reports since 2015, convictions have plummeted by almost 60% in the same timeframe.
