We’re fighting to protect our waters by advocating against HB 138, a bill that would shift a science- based process to declare protected waters at the DEC into a political game, with an appointed commission by the Governor. ADF&G, “Topics to be addressed within the Interior and Eastern Arctic Region include hunting and trapping seasons and bag limits for residents and nonresidents, restricted and management areas including closed areas to hunting and trapping wolves near Denali National Park, methods and means, salvage requirements, hunting permits and conditions, and intensive management plans. The board will also address annual reauthorizations of antlerless moose hunts and resident brown bear tag fee exemptions statewide. Per Alaskans For Wildlife: “Alaskans FOR Wildlife is asking the Board Of Game (BOG) to AMEND PROPOSAL 152 **to enact a year-round no kill buffer** as enacted in HB 105 by the House of the Ak Legislature in 2017, but to include not only Denali Park wolves but also bears black and brown, wolverine, lynx and coyotes that stray outside northeastern park bounds and, without the buffer get legally killed at bait stations, in snares and traps or shot on site. Proposal 152 would allow killing August through January and halt it during only spring months... Any support for 152 unfortunately is a way to ensure the BOG will likely not again accept proposals for the needed year round buffer that once existed.”

****More detail about FNSB proposed [Resolution 2020-17](#) supporting basing KC-46A at Eielson Air Force Base:** KC-46A is “a widebody, multirole tanker that can refuel all U.S., allied and coalition military aircraft compatible with international aerial refueling procedures. Boeing designed the KC-46 to carry passengers, cargo and patients. The aircraft can detect, avoid, defeat and survive threats using multiple layers of protection, which will enable it to operate safely in medium-threat environments.” (per Boeing.com) The Resolution includes this: “WHEREAS, Eielson Air Force Base anchors the Joint Pacific Alaska Range Complex comprised of 67,000 square miles of airspace, 1.6 million acres of maneuver training lands and related 48,000 square miles of surface, subsurface and overlying airspace in the Gulf of Alaska...”

Notes about the expiring contract: For about five months in 2019, Bus #75 did not circulate on any routes due to mechanical problems. To compensate for that lack of circulation, LFM provided an additional copy of the APC message on a second bus, #71, to run for seven months at no charge, and also radio air time for an APC message. APC is grateful for these significant and generous compensations, and believes that LFM has definitely indicated good faith regarding their contract(s) with APC.

While looking over a poster that Heather had made for a presentation that I gave Oct. 10, 2013, titled *No Winged Robot Assassins North*, she asked me if I could elaborate on the **military doctrinal terminology** that was briefly addressed on the poster.

The terms listed
were:

"**operate**" = Sounds harmless enough; after all you could operate an automobile, a handsaw, or an ice cream maker, right? The term is a euphemism and or a distraction for the making of war

"**Network Centric Warfare**" = Refers to the networking the war-fighting **enterprise** (shooters, decision

makers, and sensors) to translate information superiority into combat powers, to be wage against those who have the temerity to hold up economic integration with the Wall Street Broker Wheeler Dealer hegemon's global rule sets.

***"Global rule sets"** = Not to be confused with international treaties, humanitarian law, or declarations of human rights these are rules governing nations & peoples, written for the benefit of, by, and at the behest of those same corporate and banking interests*

***"Battlespace transparency"**= Military Forces ability to see anywhere they want, e.g. the National Security Agency spying on your communications or the National Geospatial-Intelligence Agency creating an active predictable model of your or your community's daily activities.*

***"Common Operating Picture"** = The acronym, "COP" says it all. This involves massive ongoing data collection, spy devices, anthropology, current and stored video and other data of neighborhoods, purchases, phone records, social media activity, any info that can be used to achieve and maintain dominance.*

***"COTS"** (commercial off the shelf technology) = The use of the speculative forces of the market to drive the development of implements of war making.*

***"Neutralize Bad People"** = Extra Judicial Killing of alleged (manufactured) enemies (generally those targeted for holding up the economic integration previously mentioned)*

***"Non State Actors"** = People; individuals and or groups; anywhere*

***"Splat"** = Confirmation by a drone operator of having killed a human being*

While attending an Institute for Defense and Government Advancement conference on military drones in 2014 I heard Dr. Bill Powers of the Marine Warfighting Lab, the events key-note speaker say of weaponized drones, "These systems are needed to help those 18, 19, 20 year olds who are out there doing god's work," The so very young Bob Dylan and Joan Baez question that assertion, in With God On Our Side."
