“...Given the increasing concern for new cases of COVID-19 being transmitted via community spread within the state, Governor Dunleavy and the State of Alaska are issuing the following mandate to **go into effect March 28, 2020 at 8:00 am and will be reevaluated by April 11, 2020...**

“**Health Mandate 012 – Intrastate Travel – Limiting travel between communities to critical infrastructure or critical personal needs.** Effective 8 am March 28, 2020... to avoid introducing new COVID-19 cases into Alaska communities and slow the spread of the virus in state. It is imperative that Alaskans heed these guidelines.

“**Health Mandate 011 – Social Distancing** - Effective 5 p.m. March 28, 2020: **All persons in Alaska, except for those engaged in essential health care services, public government services, and essential business activities, are mandated to remain at their place of residence and practice social distancing... six feet or greater from any individuals with whom you do not currently reside...** cease participation in public or private gatherings that include non-household members, regardless of the number of people involved.

**The Governor orders the closure of non-essential businesses.** Critical infrastructure includes those items listed in “[Alaska’s Essential Services and Critical Infrastructure](#)” (formerly Attachment A) [Lists Healthcare Operations, Essential Infrastructure, Financial services sector, First Responders, Essential Government Functions, Essential Business (20 categories, ending with “businesses that can maintain Social Distancing Requirements and ...no more than 10 people in the business at a time(including employees).”

“ADOPTION OF FEDERAL GUIDANCE.a. This Order incorporates:

“A violation of a State COVID-19 Mandate may subject a business or organization to an order to cease operations and/or a civil fine of up to \$1,000 per violation....”

This grave pandemic demands a comprehensive and all-encompassing response from us all. **Our elected leaders in the Alaska Legislature are meeting right now to take important legislative steps with HB308, HB310 and SB24.** It is critical to ensure that bailout dollars go directly to working people and not corporations.

The scale of needed assistance is likely to be massive and matched only by a few other dire historical events, and it calls for exceptional action. [Please review our policy recommendations](#) in this letter and send to your representatives **TODAY**.

*\*from Louie Flora, AK Center Government Affairs Director, on Friday, 3/27/20 at 4:50pm: "...the state operating budget and supplemental budget being negotiated today contain \$100 million in COVID-19 response funds to Alaska. **House Minority Republicans blocked over \$100 million in funds in the FY 19 supplemental budget designated to cover unanticipated 2019 costs from the wildfire season, Medicaid, and additional monies added for COVID-19 aid.** They did so by withholding the necessary 3/4 vote to access the Constitutional Budget Reserve, a strange move considering the urgent need for funding in this public health emergency that is mangling our economy. The Governor will now have to cut the already slim state government by \$100 million to cover the shortfall.*

**"SB 241 - the comprehensive COVID-19 emergency response package passed ....** This bill puts requirements on state agency functions during the public health emergency. [You can read the full list here.](#) One significant provision of this bill is a direction to the Division of Elections to hold upcoming Primary and any Special election votes by mail.

**"SB 242 is an act that extends deadlines for actions by state agencies.** It modifies income determinations for specific public assistance programs and pauses action against borrowers who owe money on state loans. SB 242 establishes a temporary moratorium on certain mortgage foreclosures, certain evictions from rental properties, and disconnection of residential utilities. SB 242 is in the Senate Finance Committee. Some provisions of this bill are contained in two bills under consideration in the House - HB 310, which is in the House Labor and Commerce Committee. HB 310 and SB 242 will likely be reconciled into a single consumer protection package.

**"HB 308 is legislation... that waives the standard one-week waiting requirement to begin receiving Unemployment Insurance benefits and increases the weekly per-dependent benefit from \$25 to \$75.** This would provide some relief for families who have lost childcare and income simultaneously. This critical bill flew through the legislative process and was signed into law on March 23. [MORE LEG WITH LOUIE](#)

*From Fairbanks Housing and Homeless Coalition: "Updates for March 27 - Our local housing/homelessness services continue to function while taking appropriate COVID-19 precautions. Our shelters remain open and have implemented COVID-19 protocols...*

"Fairbanks Rescue Mission ... After following the CDC's six-foot guidelines, FRM has 73 beds available for men, and 42 for women and children. So far we have no positive cases of COVID-19 at our shelter and we are working to keep it that way... **Warming Center(s):** With so many public places closed for COVID-19, No Limits' Warming Center was facing a large spike in attendance. This was making social distancing problematic, so our awesome local organizations came together to establish a second warming center... The hours of the second warming center are designed to serve as backup for No Limits' busiest hours then go on to ensure guests get supper. Now people can get breakfast at Stone Soup Cafe, lunch at No Limits Warming Center, and dinner at the Encampment Outreach Warming Center. The Bridge Warming Center at JP Jones Center, 2400 Rickert St, use the back entrance, beginning Tues, March 31, Mon-Fri 1-6pm until further notice; Charge cell phones, get needed supplies, eat a warm meal 4-6pm, case management & peer support, sew a facemask for yourself or someone else, learn about community resources during the Covid19 crisis. We will be using social distancing (6' apart). We encourage all to wash your hands when you enter the building and avoid personal contact and touching your face. If you are ill we ask that you call before entering the building, 907-799-5270."
