"New Study: Intensified Police Militarization is a Direct Consequence of U.S. Post-9/11 Wars

The report analyzes how the United States' militarized response to 9/11 included a new mandate and new resources for local law enforcement based on the premise that they would be on the front lines in a domestic war against terrorism. This had the effect of intensifying the militarization of police through an influx of military weapons and equipment, ramped-up surveillance and intelligence-sharing, and increased hiring of combat veterans as officers.

"The report reveals that the Department of Defense's 1033 Program has transferred at least \$1.6 billion worth of equipment to law enforcement agencies since 9/11, including at least 1,114 mine-resistant vehicles and more than 1,000 robot items..."

"The study's author, Jessica Katzenstein, says, 'Police militarization comes at a high cost: it is expensive, it works against the stated goals of law enforcement, and, most significantly, it normalizes racialized violence on communities at home and abroad.'

"Vote-at-Home for Our Health -

Despite Senate Bill 241 (passed by the Alaska Legislature in late March and signed into law by Gov. Dunleavy on April 10, 2020) which provides that for the duration of the coronavirus emergency declaration, "the director of the division elections may conduct all elections ... by mail," the Lt. Governor's team has not used the power of his office to protect the rights of all eligible Alaskans to vote this year. The Division of Elections announced six last-minute polling place closures on Primary Election Day, disenfranchising 1000+ Alaskans who could not access an absentee-in-person ballot that day.

"Moose Picks ... Hello this is Rob Mulford, the Asymmetric Moose, with picks for the week of September 20, 2020.

Thank you, Heather, for another invaluable contribution to your insightful and comprehensive weekly presentation of the news as it relates to issues of peace, justice and sustainability, how they effect our community and those opportunities we have to affect the just, healthy, and peaceful world we so desperately need and desire.

Hello this is the Asymmetric Moose, Rob Mulford, with picks for the week of September 20, 2020. I have come to find it a bit strange and more than a little disconcerting that most of our local media (this station being the notable exception) takes announcements of the further militarization of our community as an invitation to breakout the Champaign and party poppers. As often is the case, I have picked a couple articles out of recent issues of the Fairbanks Daily News Miner as the catalyst of my musical picks of the week. The two that I have picked for this week fall into that celebration-come-darkly motif.

The first - appearing in the Sunday, September 13th edition titled "***New wing commander says Eielson is on track to get all 54 F-35s by the end of 2021***" is a congratulatory piece celebrating U.S. Air Force Col. David Berkland getting his "***number one pick for wing command***", ***Wing Commander for the 354th Fighter Wing, Eielson Air Force Base***, with the exuberantly smiling colonel saying, "I knew that the flying up here was fantastic, the training was amazing, the landscape was beautiful, *[discounting possibly that part of the landscape that has been burned by bombing]* the people were friendly and super supportive." But, what really tickled his fancy was the challenge of his assignment; turning the training wing into a combat mission. As Col. Berkland explains it, "What comes along with that is really a change in mentality too, from a garrison mentality to a warfighting mentality and it's any commanders main job to establish the culture of an organization, which I am excited to do."

The second article was an editorial piece by the Washington Post's David Ignatius declaring: "***In this election, the US military has our backs***". Applauding the "U.S. Cyber Command's quiet pushing ahead with efforts it started two years ago to "defend forward" *[a sample of doublespeak that rings like War is Peace, Freedom is Slavery, Ignorance is Strength, and 2 + 2 = 5]* against Russian influence operations, which means getting inside Russian cybernetworks to detect and disrupt attacks." Efforts that Ignatius says will make it "virtually impossible" for Russians or anyone else to

penetrate voting systems in the roughly 8,000 jurisdictions around the country.” Among the vague and unsubstantiated threats promulgated in the piece was this little gem of a perfunctory disclaimer, “Measuring Cyber Command’s success is impossible. We don’t know what the Russians or others are planning this year, or whether they’ve been deterred.”

From 2010 to 2013 I attended a series of conferences held by the Institute for Defense and Government Advancement, spanning a gamut of issues ranging from Unmanned Aerial Vehicles, to Special Operations, to Nontraditional Intelligence Surveillance and Reconnaissance. Most of the presentations in these meetings were screened to remove the presence of media unaffiliated with the war industry. One of these, the Special Operations Summit, held in Tampa, Florida, Dec. 12th to the 14th 2011, centered largely on, guess what, *surprise*: the use of Social Media in the influence of populations to suit a Commanders Intent in the carrying out of U.S. Military operations. Consider carefully the following comments made by U.S. Marine Col. Michael Lewis at that conference,

“An Eastern European officer [*and I*] talked about radicalization and assimilation up in Dearborn, Michigan… We talked about the challenges of the Muslim faith assimilating into American culture. This officer said, ‘This is very interesting. I think it’s very important but it’s not my job. This what the civilians do and this what they think about and I just work for the civilians. So as a military officer it’s not my problem.’” Colonel Lewis continued, “Well, my first response to that was, ‘well that’s nice’. But then as I thought a little bit more, that’s a luxury that he as that we don’t have! Our military is going to be and will be involved in all aspects of preventing, resolving, and conducting conflict.”

And

“Another opportunity that I have in my position is taking a look at our future leaders in Washington. This is something if you’re from the DC area, you been there often you’ve seen a lot of our current leaders don’t have time to think. We’re they’re at if focused right now on problems of national policy. That will be it. No time to think. It’s a process that just continue roll. But we take guys off the train. We sit them down and we force them to think a little....”

Or take the following quote from SOC Commander Lieutenant General Bradley Heithold that I recorded at the ISR conference. After thanking Lockheed Martin and other corporations for providing him with technology that afforded him the power to hunt and kill people, he was asked what kept him awake at night. His reply was:

“terrorism and narco-terrorism” and “I can do a real good job hunting outside the continental United States but right now the law ties my hands, Congress ties my hands. I can’t do as good a job hunting here.”

Please take the time to think critically here, if indeed there exists an external threat to what remains of our “democracy” where is it most likely to reside: in that scary bear that our former part-time Governor Sarah Palin could see from her porch in Wasilla, or the entity that plans on stationing 54 nuclear weapon equipped F-35s at Eielson Air Force Base.

Colonel Berkland, like Major General Smedley Butler warned us 85 years ago, your operation is a racket. The indefatigable defender of human rights and dignity, *Buffy Sainte Marie agrees, in The War Racket*.

A few years ago I was visiting a friend of mine living at the Fairbanks Pioneers Home. Izzy was a Veteran suffering the late stages of Parkinson’s Disease and Non Hodgkin’s Lymphoma caused by his exposure to the defoliant Agent Orange in Vietnam. I had just pinned a ribbon on his shirt calling for justice for US service member and Vietnamese victims of Agent Orange when he started to shake and cry, holding onto my arm, he leaded please, please, please drop your gun young fella. I don’t want to run my bayonet through you, please! I stayed with Izzy until he calmed and fell asleep.

However, that was the last time that I got to speak with Izzy for he died a few days later. The next song is dedicated to Izzy Israel. ***Kate Wolf sings Agent Orange.***

Today's last tune resonates in so many many ways. ***Martha Scott Stey sings Ashes and Dreams.***
